DRAFT MEETING MINUTES

I. CALL TO ORDER

A meeting of the Wyoming Department of Transportation (WYDOT) Aeronautics Commission was held on Tuesday, March 19, 2024, via videoconference. Chairman Bruce McCormack presided, calling the meeting to order at 1:38 p.m.

II. PLEDGE OF ALLEGIANCE

Chairman McCormack led the attendees in the Pledge of Allegiance.

IV. AGENDA ADJUSTMENTS

There were no adjustments to the agenda.

V. APPROVAL OF MINUTES

It was moved by Commissioner Maier, seconded by Vice Chairman Blann, and unanimously carried to approve minutes from the February 14, 2024, business meeting and the February 13, 2024 education session.

VI. UPDATES/DISCUSSIONS

B. DIRECTOR'S UPDATE

Director Westby presented the Director's Update.

Stakeholder Presentations

Director Westby reported that he recently attended meetings of the Concrete Association of Wyoming, the Wyoming Telecommunications Association, and the Association of General Contractors to provide a high-level overview of WYDOT and report on the future direction of the department under his leadership. He hopes that these presentations inform audiences on the department's future needs while connecting stakeholders to WYDOT's mission.

Governor's Prayer Breakfast

Director Westby and other members of executive staff attended the Governor's Prayer Breakfast on February 21, 2024. The keynote speaker was (retired) Major Scott Smiley—the first blind active-duty service member—and the main theme of his address was to live every day with courage. The director found it to be a particularly impactful and inspiring message.

Wyoming 22 Bridge Reconstruction

Director Westby reported that he has received much feedback on the bridge reconstruction project in Teton County and he is working with the local WYDOT office to address community concerns. The team is adjusting the traffic signals to improve traffic flow as much as possible, but congestion will still occur because of the high volume of traffic.

Western States Leadership Meeting

The director shared that he is currently in Sheridan for the Western States Leadership Training. WYDOT, and transportation departments from several neighboring states, send selected staff to participate in educational workshops and discussions on various leadership topics and transportation issues. Each state sends diverse representation from within its agency in order to facilitate wide-ranging discussions that lead to innovative and comprehensive solutions.

Legislative Update

Director Westby reported that the 2024 Budget Session has been a major focus for the past month. The legislative session concluded last Friday and Governor Gordon now has two weeks to take action on a number of bills. The director cautioned that, depending on the Governor's veto or signature, the status of certain bills could change drastically.

During the session, WYDOT followed 44 bills in the House and actively tracked the progress of 19 bills, providing support and testimony where necessary. Six of those bills resulted in enrolled acts and three are high priority bills for the department. House Enrolled Act (HEA) 0013 will allow drivers who are 18 years old to receive a hazardous materials endorsement for a commercial driver's license. HEA 0032 amends the deadline for providing fuel tax return and license information when it is requested by the department of transportation. HEA 0041 requires the calculation of employee and employer contributions for the public employee retirement plan to be based on an actuarially determined contribution rate.

WYDOT monitored 18 bills in the Senate and actively tracked 10 bills, which resulted in five enrolled acts. Senate Enrolled Act (SEA) 0014 increases employee contributions under the

Wyoming State Highway Patrol, Game and Fish Warden and Criminal Investigator Retirement Act. SEA 0035 creates a penalty—a \$1,000 fine—for violating signs and markers for closures to light and high profile vehicles and other weight-based closures.

The general government appropriations bill had 64 amendments: 36 in the House and 28 in the Senate. The department actively tracked 25 of the amendments. Employee compensation increases were included in the final bill. Another budget amendment will provide the governor with flexibility in spending American Rescue Plan Act (ARPA) funds on eligible projects. An amendment that would have required WYDOT to undergo an organizational effectiveness study failed.

Interim Topics

At the end of the session, the department had the opportunity to submit interim topics for committee consideration. Director Westby shared that while WYDOT was mentioned frequently and positively during the session, there is still a need to improve legislator perception of the agency and increase understanding of agency operations. The department has requested to provide education sessions to the Joint Transportation, Highways, and Military Affairs Committee, the Joint Appropriations Committee, and the Joint Revenue Committee. The session would include information on WYDOT's mission and impact, the history of department funding, and future needs.

The second priority for the interim is safety, education, and improvements for motorists. Safety initiatives include distracted driving, seatbelt laws, car seats for babies and children, and fines for speed limit violations. The goal for new legislation would be to change motorist behavior to improve safety and save lives on Wyoming roads and highways.

Finally, the department requested a general review and update of old, outdated transportation statutes.

In response to comments from Vice Chairman Blann on Wyoming 22 traffic congestion, Director Westby stated that WYDOT remains committed to improving the situation and is actively working on solutions and mitigations. Crews are working on patching potholes on the bridge, but that does add to traffic delays. The team is also working to refine the timing on the traffic signals to alleviate congestion.

In response to a comment from Commissioner DeVore on large sand particles on Interstate 25, Director Westby will work with Operations to learn more about how the salt/sand mixture is applied to roadways. Following a question from Chairman McCormack, Director Westby reported that WYDOT received support from a broad range of legislators during the session.

C. ADMINISTRATOR'S UPDATE

Administrator Olsen presented the Administrator's Update.

Federal Updates

Fiscal Year (FY) 2024 Appropriations

On March 8, 2024, Congress passed six appropriations bills and secured the FY 2024 transportation appropriations. Administrator Olsen reported that the appropriations relating to the Federal Aviation Administration (FAA) are a continuation of past funding levels. While total Airport Improvement Program (AIP) funding remains flat at \$3.35 billion, the bill includes \$530 million of supplemental discretionary funding—of which \$480 million is earmarked for specific projects. Administrator Olsen said that remaining \$50 million will be allocated based on competitive grants, but he does not expect Wyoming will receive much, if any, of the funding.

Jackson Hole Airport did receive \$3 million for its deicing pad from an earmark submitted by Representative Hageman.

The bill also provides funding for 1,800 new air traffic controllers in FY 2024. The air traffic controller shortage severely affects the East Coast, but effects do trickle out to the western half of the US.

Administrator Olsen shared that, overall, the bill provides a solid funding package for aviation. The bill also included generous funding for FAA facilities and equipment to update the airspace system.

FY 2025 Appropriations

On March 11, 2024, the Biden Administration released its proposed FY 2025 budget to Congress, just days following the passage of the FY 2024 appropriations. The proposed budget includes funding for an additional 2,000 air traffic controllers to assist the FAA in managing the airspace system.

FAA Reauthorization

Congress extended the current authorization to May 10, 2024, to provide more time to complete the five-year bill. The House and Senate are still reconciling the two versions of the bill. From Administrator Olsen considers the House bill to be more helpful and beneficial to small and General Aviation airports, while the Senate bill is more helpful to commercial service airports. Administrator Olsen remains hopeful that Congress will pass a reauthorization bill that is helpful to all airports.

Per- and Polyfluorinated Substances (PFAS) - free Firefighting Foam Transition

The FAA recently shared the Department of Defense's (DOD) requirements and guidelines on transitioning to PFAS-free firefighting foam. The agency's intention was to provide airports with a reference point and general guidance—the DOD requirements are not mandatory. The DOD requirements prescribe a single water rinse of the fire fighting and extinguishing systems on fire trucks, which will remove most of the PFAS.

State Updates

National Championship Air Races

On February 29, the Reno Air Racing Association announced three finalists for the new National Championship Air Races host community. Casper is one of the three finalists along with Pueblo, Colorado, and Roswell, New Mexico. The division will do all it can to support Casper's bid. A final decision is expected later this spring.

2024 Budget Session

Administrator Olsen reported that aviation was not a significant topic within the legislative session. However, the state set aside \$2.5 million from the Tourism Reserve Account to provide a match for the Casper Airport in the event that they are selected as the new host city for the air races.

Washington D.C. Trip

Administrator Olsen traveled to Washington D.C. with the Wyoming Airport Coalition's Legislative Affairs Committee to meet with Wyoming's congressional delegation. The group met with Senator Barrasso and Representative Hageman to discuss Wyoming's priorities for FAA Reauthorization, the challenges to air service and aviation in Wyoming, and suggested potential federal legislation or regulatory action.

Airport News

Administrator Olsen announced that Tim Bradshaw, director of the Cheyenne Regional Airport, is retiring on July 1, 2024. The Cheyenne airport will begin a search for a new director soon.

D. AIR SERVICE DEVELOPMENT PROGRAM UPDATE

Ms. Johnson presented the Air Service Development Program Update.

General Matters

February Traffic

Ms. Johnson reported that February load factors were lower than the totals from the last two months of 2023, which is typical for winter. Gillette and Cheyenne experienced robust load factors in February—81 and 74 percent respectively.

Future Bookings

Ms. Johnson reported that March bookings are trending upward from the seasonal dip that occurred during the first two months of 2024. April and May bookings indicate that demand will be strong in spring and summer.

Industry Updates

Ms. Johnson reported that JetBlue and Spirit Airlines terminated their proposed merger earlier this month. JetBlue initially appealed the federal court's block, but ultimately decided to end the appeal as it was not the best use of either company's resources. Both airlines are now focusing

on individual recovery plans. JetBlue and Spirit Airlines were among the worst financial performers in 2023, and each company will have to work hard to regain profitability.

The four largest US airlines—American, United, Delta, and Southwest—have all announced a planned slowdown in pilot recruitment as aircraft manufacture delays and engine issues limit fleet growth. Industry experts hope that this slowdown will allow regional airlines to recruit pilots and begin to recover from the shortage.

United Airlines recently announced a restructured internal fleet plan to account for delayed aircraft deliveries. The airline has 150 Boeing 737 MAX 10 aircraft on order, but the aircraft are not certified and will not be available in the next three to four years. United has requested that Boeing pause the order and instead focus on 737 MAX 9 aircraft, which are already certified and in United's fleet.

American Airlines recently announced an order of 260 aircraft including 85 Boeing 737 MAX 10 and 85 Airbus A321neo aircraft. The airline also ordered 90 Embraer E175 regional jets to support its plan to retire all 50-seat regional jets from its fleet by the end of the decade.

Standard Reports

Air Service Enhancement Program (ASEP) Budget Forecast Report Ms. Johnson reported no changes to the ASEP Budget Forecast Report.

Capacity Purchase Agreement (CPA) Budget Forecast Report

Ms. Johnson reported that the CPA Budget Forecast Report was updated to include January and February amounts for each airport.

Percent of Grant Projects by City Report

Ms. Johnson reported no changes to the Percent of Grant Projects by City Report.

Monthly Load Factors Report

Ms. Johnson reported that the Monthly Load Factors Report was updated to include the most recent load factor data available for each airport.

In response to a question from Commissioner DeVore, Ms. Johnson clarified that the Monthly Load Factors report contains an additional page with totals by route because the 2023 figures are still coming in. One page of the report is the 2024 totals and the second page includes the 2023 totals received to-date.

Administrator Olsen explained that the Boeing 737 MAX 10 aircraft manufacturing delays prevent United from "upgauging" across the airline's entire system. This would have made smaller aircraft available for other routes and been very beneficial to Wyoming as more markets transition to larger aircraft.

E. ENGINEERING AND CONSTRUCTION PROGRAM UPDATE

Mr. Hearn presented the Engineering and Construction Program Update.

General Matters

Crack Seal Project Update

Mr. Hearn reported that the crack seal project is underway. Once the commission approved the contract at the February meeting, a Notice to Proceed was issued on March 4 and work began on March 11.

Seal Coat and Mark Project Update

Mr. Hearn reported that bids for the seal coat and mark project were let on March 14. The bids came in well and contain unit prices that compare favorably to last year's project. The bid results will be in next month's packet. The low bidder was about \$540,000—or 26 percent—under the engineer's estimate.

General Projects Update

Mr. Hearn reported that the FAA funding delays might result in the late issuance of grants for this year's projects. He cautioned that grants might be issued as late as end-of-May or early-June. It is possible that bids will be let this year but construction will be delayed to 2025. The division is working with the FAA Denver Airports District Office (ADO) on this issue.

Standard Reports

Change Orders Report

Mr. Hearn reported two new change orders for a Jackson project.

Statewide Line Items Report Mr. Hearn reported five new lines items.

Bid Summary Report Mr. Hearn reported two new bid results.

F. PLANNING AND PROGRAMMING PROGRAM REPORT

Administrator Olsen presented the Planning and Programming Program Update.

General Matters

Staffing Update

Administrator Olsen reported that Eric Wyatt, the division's senior planner, is resigning in April. He is leaving the division to pilot A-10s in the Missouri Air Force Reserve. Administrator Olsen thanked Mr. Wyatt for his work for the division and wished him well in his new endeavors.

Transportation Infrastructure Finance and Innovation Act (TIFIA) Loans

Administrator Olsen reported that the TIFIA loan program—administered through the Build America Bureau—considers loans for airport-related projects through the Bipartisan

Infrastructure Law. The loans offer low interest rates, which do not start to accrue until funds are drawn. Loan repayments are also deferrable up to five years after the project is complete. Loans may be made for up to half of a project's eligible costs and project sponsors must provide the remaining funding.

The division will share this funding opportunity with the airports, but Administrator Olsen stated that he is unsure how many airports will take advantage of this program as most avoid debt.

Standard Reports

Administrative Approvals Report

Administrator Olsen reported there were no administrative approvals this period.

Recovered State Funds Report

Administrator Olsen reported four recoveries this period totaling \$4.20. The total recovered for FY2024 is now \$79,639.13.

G. UNMANNED AIRCRAFT SYSTEMS PROGRAM UPDATE

Ms. Taylor presented the Unmanned Aircraft Systems (UAS) Program Update.

General Matters

Drone Incident

Ms. Taylor reported on a drone crash that occurred last month during a standoff with the alleged shooter of Sheridan Police Sergeant Nevada Krinkee. In an attempt to locate the suspect during the standoff, the Wyoming Highway Patrol flew a Parrot ANAFI USA drone into the house through a gap in the basement doorway made by a Bearcat armored vehicle. One of the drone's propellers struck a wall as it entered the doorway, causing the drone to crash. No attempt was made to retrieve the drone due to the high risk of the situation. Later efforts made by the SWAT team to dislodge the suspect likely ensured the drone's destruction.

The division and WHP are working with WYDOT Risk Management to replace the drone as it was deemed a total loss. A safety board meeting held last week found that the pilot followed all proper procedures during the incident.

In response to follow up questions from Chairman McCormack, Ms. Taylor stated that the Parrot ANAFI drones do not have the same collision avoidance systems as the Skydio drones. It is more challenging to manually fly a drone through a small opening, especially during a tense situation. Insurance will cover the cost of replacing the drone.

VII. REGULAR BUSINESS

A. FY 2024 WACIP BUDGET MODIFICATIONS

Administrator Olsen reported two modifications this period for a reduction of \$29,498 in state funds and \$428,775 in federal funds allocated towards projects. The remaining state reserve is currently \$1,858,161.

Administrator Olsen shared that the reserve is currently higher than normal, but it will be used as more projects are bid out. The division has also maintained higher reserves due to uncertainty about the timing of projects using Infrastructure Investment and Jobs Act (IIJA) funding.

<u>Action</u>: It was recommended by Administrator Olsen, moved by Vice Chairman Blann, seconded by Commissioner Harrop, and unanimously carried to approve the FY 2024 WACIP budget modifications as presented.

B. WACIP SPONSOR COMMENTS

Administrator Olsen reported that the WACIP Sponsor Comments report includes the airport sponsors comments as well as the division's response, made in coordination with the FAA Denver ADO. The sponsors submitted comments on the proposed WACIP draft for FY 2025 Budget and FY 2026 through FY 2030 Program during the 30-day comment period, which ended February 2, 2024. Any funding changes that were made in regards to comments are incorporated in the FY2025 Budget and FY2026 - FY2030 Program.

Administrator Olsen reported that the division received comments on 37 projects from 10 airport sponsors. The comments provide guidance to airport sponsors on suggested next steps for projects that did not receive funding.

Administrator Olsen reported that many of the comments offered further explanations or updates on the project instead of requesting a specific action. A few of the comments received were specific to FY 2024, which is the current fiscal period. These comments were removed and will be addressed through the monthly budget modification process.

Administrator Olsen noted that the large number of comments for Jackson Hole Airport resulted from a reordering of federal projects based on the availability of federal funding in the upcoming fiscal years.

Administrator Olsen reported that an increase of \$8,000 in state funds for FY 2025 was allocated due to comments. A reduction of approximately \$40,000 in FY 2026 was due to a Gillette aircraft rescue and firefighting (ARFF) project that was brought forward to 2024. In FY 2027, there was an increase of \$296,000 in state funds due to requested changes in Jackson's capital improvement plan. There is an increase of \$40,000 in state funds in FY 2028 that was allocated to a project in Riverton.

C. PROPOSED FY 2025 WACIP BUDGET

Administrator Olsen reported that changes have been incorporated into the proposed upcoming budget based on sponsor comments, FAA concurrence, and staff input. The remaining reserve is \$1,007,034 in state funds. This reserve is \$8,000 less in state funds than when the draft budget was presented in December, due to a change resulting from sponsor comments. The division's target reserve is \$1,000,000.

<u>Action</u>: It was recommended by Administrator Olsen, moved by Vice Chairman Blann, seconded by Commissioner McClain, and unanimously carried to approve the final FY 2025 WACIP budget as presented.

D. PROPOSED FY 2026-30 WACIP PLAN

Administrator Olsen reported that changes have been incorporated into the proposed upcoming budget based on sponsor comments, FAA concurrence, and staff input. The remaining reserves have changed according to the changes requested.

The FY 2026 reserve is \$923,032 in state funds, which is \$40,000 more than when the Plan was presented in December due to the Gillette ARFF project. The target reserve is \$1,000,000.

The reserve for FY 2027 is \$617,073 and is \$296,000 less than when the Plan was presented in December due to changes made because of sponsor comments. The FY 2028 reserve is \$455,972, which is \$40,000 less than the previous draft due to the Riverton project. The reserve for FY 2029 is slightly over \$2,000,000 and FY 2030 is \$2,200,000.

<u>Action</u>: It was recommended by Administrator Olsen, moved by Commissioner Maier, seconded by Commissioner Harrop, and unanimously carried to approve the final FY 2026-30 WACIP plan as presented.

VIII. NEW BUSINESS

A. CONSIDERATION OF THE NATRONA COUNTY BOARD OF COUNTY COMMISSIONERS GRANT AMENDMENT REQUEST

Ms. Johnson reported that the Natrona County Board of County Commissioners requested an increase in state funding of \$399,268 for project ASCPR04 in order to continue service from Casper to Salt Lake City (SLC) through June 30, 2024. This would bring the total state support to \$719,268 and the project total to \$1,798,171.

Mr. Januska shared that the grant amendment is needed because the current grant—which was anticipated to last until the end of June 2024—is insufficient due to lower than anticipated load factors. SkyWest Airlines also recalculated the block hour rate to account for the larger aircraft. He believes that reliable air service—from two major airlines—will be a key component of Casper's bid to host the National Championship Air Races.

Following a question from Chairman McCormack, Mr. Januska shared that the Natrona County Commissioners discussed the local match at a work session that was concurrent with the Aeronautics Commission meeting. The county commission will take formal action (vote) on the proposal later in the evening.

In response to questions from Commissioner Duck, Mr. Januska believes that losing the SLC route would be detrimental to Casper's bid to host the air races. Mr. Januska was also unable to predict if the route would need continued support into the future. The booking trends for the next several months are improving, but he could not say with certainty that future minimum revenue guarantees (MRG) would not be needed.

Mr. Januska shared that the airport and the Fly Casper Alliance have launched a marketing campaign in SLC to draw customers to the route. He believes that it has resulted in improved booking trends. Other existing marketing campaigns are ongoing.

Following a question from Commissioner Maier, Administrator Olsen shared that future bookings will be key criteria when the commission decides on supporting the route past June 30. A final decision will need to be made in the next two to three months to accommodate the booking window—the 60 days before the flight when most airfare is booked. The division has shared its concerns with SkyWest Airlines about the future viability of the route.

Chairman McCormack agreed that the commission and the airport has a responsibility to SkyWest and the traveling public provide notice on the availability of the route, but he believes there is still time to make an informed decision in the next two months.

Vice Chairman Blann expressed concern about the amount of total funding that the route has received. He thought that the commission's support of the request should be contingent on improved load factors and a funding commitment from Natrona County. He also requested that Ms. Johnson and Mr. Januska share the pre-booking data—through June—for the route to help the commission make an informed decision about the future of the route beyond the end of the current contract.

Administrator Olsen reviewed the non-directional load factors for the Casper –SLC route. The load factor for March, month-to-date, was 46.1 percent and bookings for the remainder of March were at 50.7 percent. April was booked at 23.7 percent, May at 15.7 percent, June at 12 percent, and July was at 5.5 percent.

Vice Chairman Blann requested a trend comparison between the Casper-SLC route and other routes and markets. Administrator Olsen quickly compared the Casper route to Southwest Wyoming Regional Airport. Load factors in Rock Springs, month-to-date, for March were 64.6 percent, the remainder of the month was at 66.5 percent, April at 32.9 percent, May at 16.2 percent, June at 12.3 percent, and July was at 8 percent. The load factors and future bookings were relatively close, even with the Casper-SLC route's use of a larger aircraft.

Administrator Olsen emphasized that he has already made SkyWest aware of the possibility that the route will not be supported beyond June 30. He will also inform SkyWest that the commission is not yet committed to supporting the route in the future, even if the commission decides to approve the current request.

Commissioner DeVore voiced his support for the route and a continued connection with Delta Airlines. He reminded the commission that the route uses a 74-passenger aircraft, and even a half-full (37 passengers) aircraft would equate to a 75 percent load factor on a 50-passener aircraft. Commissioner DeVore also mentioned Delta's good reputation, on-time performance, and the attractiveness of the destination as reasons to maintain the route. He was also concerned that eliminating the Delta/SLC route would increase the tickets prices on the United/Denver route.

Commissioner Duck proposed approving the request to continue service through June in the hopes that it would assist Casper's bid to host the air races, and then reassess the future viability of the route in the next few months. Commissioner Harrop requested that the commission consider how the loss of the route could impact other Wyoming airports.

Chairman McCormack endorsed Commissioner Duck's proposal as he felt it was incumbent upon the commission to complete the term of the MRG. He also urged Mr. Januska to use the Aeronautics Commission's support to strengthen the airport's request to the county commission.

Vice Chairman Blann suggested that the commission consider including spending caps in future MRGs. He felt that the MRG agreements should be consistent across all Wyoming airports. Administrator Olsen shared that generally, caps are included in the contract with the airline. The community, in the grant, requests the state's portion of the cap. SkyWest has stipulated in the contract that once the cap is reached, the airline can choose whether or not to continue service. As there are plenty of markets competing for service, Administrator Olsen believes that SkyWest would not hesitate to leave the Casper market if the state and local community did not continue the MRG.

Following a question from Commissioner McClain, Administrator Olsen explained that the funds are available to support the request. Aeronautics receives an annual allocation of \$1.3 million from the legislature and the account balance is currently at \$2 to \$3 million.

<u>Action</u>: It was recommended by Ms. Johnson and Administrator Olsen, moved by Commissioner Maier, seconded by Commissioner McClain, and unanimously carried to approve the request to increase the state funding of project ASCPR04 by \$399,268, at a state match not to exceed 40 percent.

Chairman McCormack requested that Administrator Olsen and Mr. Januska report the outcome of the Natrona County Commission's vote to the Aeronautics Commission. Ms. Chapman will send a link to the streamed meeting to the commission.

IX. EXECUTIVE SESSION

There was no need for an executive session.

X. ANNOUNCEMENTS/REMINDERS

Commission Activities

Ms. Chapman announced that the commission's next business meeting may be held at 1:30 p.m. on April 16, 2024, via videoconference, if there is regular and new business for commission consideration. The next in-person meeting will be held in Cody, and the surrounding area, on May 20-22, 2024. The trip will include tours of local airports, an education session, and the monthly business meeting.

The Attorney General's office will hold its annual board training workshop on Friday, May 10, 2024. The full-day training will be held in the Capitol Auditorium in Cheyenne, but there is a virtual option for participants who are unable to travel.

XI. ADJOURNMENT

It was moved by Commissioner Blann to adjourn and passed unanimously. Chairman McCormack adjourned the meeting at 4:03 p.m. on March 19, 2024.

Dear Commissioners:

The Wyoming Aviation Hall of Fame (WAHF) appreciates the ongoing relationship with the Wyoming Aeronautics Commission and its continued involvement in the annual selection process. The WAHF board includes myself; Dean McClain, current commissioner from Torrington; and Col. Kent Nelson, Cheyenne, retired USAF and former Wyoming Aeronautics Commissioner.

As you will recall, Tim Coleman was the 2023 inductee into the Wyoming Aviation Hall of Fame. This was a posthumous honor. The family chose to celebrate the honor privately. They will consider donating the plaque to the Central Wyoming Regional Airport in Riverton at some point in the future. Our board learned of the news of the repurposing of the old Cheyenne Airport Terminal into a cultural center that will feature an aeronautics theme. This is exciting news as it will allow the WAHF display case to remain in Cheyenne in a very appropriate atmosphere.

Regarding the 2024 induction process, the annual induction process begins with the WAHF board selecting three nominees from the pool of nominations. The WAHF then recommends one individual from this group of finalists and makes its recommendation to the Aeronautics Commission for consideration and approval. This year the board has narrowed the finalists to Rich Bastian, Dwight France, and Howard Shrum. Included in your packet is basic biographical information for the three nominees for you to review. From this short list, the WAHF selected **Rich Bastian** for recommendation as the 2024 inductee into the Wyoming Aviation Hall of Fame. Keeping in mind that most nominations the board receives are for deceased individuals, a goal of the Hall of Fame board is to induct living persons when possible. Mr. Bastian continues to operate his shop in Burns where he provides expert aircraft modification and restoration services. We recently received a nomination for Dwight France, who operated a flying service in Rawlins. Finally, Howard Shrum represents an older nomination that we received in the late 1990s. The original nomination was brief, so for years his case has been overlooked. Recently, I connected with his son who now is providing more information to complete the packet. The WAHF also is considering a joint nomination for Ray and John Elgin. Though normally only one person is inducted annually, the WAHF will consider a future joint nomination of these brothers.

Thank you again for considering Rich Bastian as the 2024 inductee into the Wyoming Aviation Hall of Fame. Always feel free to contact us with any questions, and the board encourages you to alert us of any individuals in your area who you believe might qualify for consideration into the Wyoming Aviation Hall of Fame. We appreciate all of your efforts to help preserve the rich aviation heritage in the state of Wyoming.

Dear Dean,

I'm writing to nominate Richard Bastian of Burns, WY for induction to the Wyoming Aviation Hall of Fame.

Rich soloed his Cessna 140 on Leonard Nelson's farm strip near Potter, NE in 1966, and finished his Private Certificate under the tutelage of Les Larson in Cheyenne.

He flew the 140 to Sheridan, Wy for two years of college there, and then to Broomfield, CO where he received his A & P from Colorado Aero Tech in 1969. At an airshow in Broomfield, Rich saw his first Pitts, flown by Joyce Case, and knew he had to have one.

He formed Bastian Aircraft in 1970 and was hired to restore a 1930's Beech Staggerwing. He simultaneously began construction of a Pitts for himself. Additionally, for the next few years, he performed general aircraft maintenance and seasonally crop dusted.

An FAA Aircraft Inspector Authorization was added in 1974, the following year a Citabria was acquired for basic aerobatic instruction, and 1976 found Rich in his recently completed Pitts Special winning second in the intermediate category at the US National Aerobatic Championships in Sherman, TX. Word of Rich's craftsmanship, creativity and knowledge began to circulate among the higher echelons of competition aerobatics. He experienced a surge in business from serious aerobatic competitors yearning for his performance and durability modifications. Accordingly, in '78 he was selected for the US World Aerobatic Championship Team as team mechanic, traveling to Czechoslovakia for the competition. If not busy enough, he placed first in the Rocky Mountain Aerobatic Championships that year as well. The following year he placed second in the Advanced Category at the US Nationals in Sherman, TX, then was selected for the US World Championship Aerobatic Team as mechanic and technical advisor in 1980.

The next ten years was given to building, re-building and modifying competition aerobatic aircraft. Many were one-offs, tailored to individuals' specifications, incorporating many unique custom features in a continuing effort to create a competitive edge. IO 540 and IO 720 engines were employed, enhanced control surfaces, relocated thrust lines, wing and empennage areas and shapes.

In 1982 the US World Aerobatic team competed with ten aircraft. Five of them were built or modified by Rich. I urge you read the selected articles in the accompanying magazines for in-depth details.

In 1991, Rich was asked to build a replica of the first Pitts for the EAA Air Museum. See the accompanying article in Air Progress.

Bastian Aircraft produces planes that not only perform, but also display a level of fit and finish found only on the finest restorations, with no detail overlooked. Noting his meticulous craftsmanship, a Saint Louis patron selected him to restore five 1930's Wacos for his museum. A ten year effort.

These last ten years has seen the restoration of several Super Cubs, Pitts, and currently his personal Stearman in AAC colors. In addition to building superb museum pieces for people of means, Rich has generously given hundreds of hours of labor and wisdom to dozens of aircraft owners who, during their "diy" restorations, found themselves in over their heads.

I find it a source of pride that so many, from the world over, wanting only the best for their restorations and with the means to ship them anywhere, often choose Burns, Wyoming, and Richard Bastian's fifty year commitment to excellence.

I urge you to afford him every consideration.

Dwight H. France Rawlins, Wyoming April 3, 1947 – March 22, 2022

In 1956, Dwight France's father John bought a brand-new Cessna 180, and it was love at first site for 9-year-old Dwight and his twin brother. It did not take the brothers long to figure out that whoever mowed the lawn first got to go for an airplane ride. Although their dad was not a Certified Flight Instructor, he taught his sons basic flight skills. While John would take off and land in the taildragger, he allowed the boys to each fly a leg of many family flights.

Following high school graduation in 1965, Dwight attended the University of Wyoming where he received a Bachelor of Arts degree in business administration in 1970. While at UW, he was a member of the Laramie Flying Club. He received instruction from several local pilots and soloed there in the late 1960s. His introduction to instrument flying began under Don Veal, a university professor who later served as President of UW.

Dwight returned to Rawlins in 1970 and went to work for his dad at Rawlins National Bank as a teller. He continued to receive instruction from several experienced Rawlins pilots: CFI Roy Rasmussen, who also worked at Rawlins Flight Service; and John Fryback, who flew for the Carbon County Predator Board. Several years later, Dwight bought a C210, obtained a charter certificate and began flying passengers when not working at the bank.

According to family lore, on one particularly nice summer afternoon, Dwight was working on the teller line. Some sort of aircraft was landing in Rawlins, and he went to the window to watch. His dad observed everything and reportedly said "You're going to have to decide what you want to do: work here or fly." Dwight chose the latter.

That was the beginning of his very successful 36-year career owning and operating France Flying Service. In addition, Dwight also ran the Rawlins FBO and served as airport manager. His FBO and charter services included aircraft maintenance; charter flights; wildlife tracking and telemetry work; fire reconnaissance; aerial photography; air ambulance services; aircraft rental; and numerous search and rescue missions, undertaken in rugged terrain and compromising weather conditions.

Dwight's first twin engine plane was a Piper Seneca. He replaced it with a Cessna 303 and his fleet eventually included a Super Cub, C180, C182, C206, C210, C340 and C421.

From 1975 to 2011, Dwight chartered passengers all over the United States, Canada and Mexico and logged nearly 40,000 hours during his accident-free career. He especially enjoyed the wildlife studies and telemetry work he did with many biologists. They appreciated his work too, and in 2011, the Wyoming Chapter of the Wildlife Society honored him with the "Citizen of the Year" Award. That award is given to someone who does not work in the wildlife field, but whose professional efforts directly benefit wildlife.

He was an avid outdoorsman and was happiest when fishing, elk hunting or looking for blue grouse. He and Candace Carroll married in 1984 and have one daughter, Jane. Dwight served the Rawlins Fire Department and Carbon County Fire Department for many years and was the County Fire Warden for 17 years. He was deputized by the Carbon County Sheriff's Office and assisted the Sheriff's Office with numerous prisoner transfers.

Dwight was a 50-year member of AOPA, and a lifetime member of the University of Wyoming Alumni Association and former board member. He was also a member of the Sigma Chi fraternity. He died on March 22, 2022.

His daughter Jane now owns the 180 with Jace Myran. It is hangered in Cheyenne and flown regularly.



HOWARD ARNOLD SHRUM

January 18, 1915 ~ November 16,1999

Howard Arnold Shrum, longtime Sheridan resident, passed away on November 16, 1999, at the VA Medical Center, at the age of 84.

Mr. Shrum was born on January 18, 1915, on a ranch near Lusk, Wyoming to Lee Henry and Leona Bottom Shrum. He attended grade school in a one room schoolhouse which was 1¹/₂ miles from his home. Later, he graduated from Lusk High School in

1934. He always wanted to fly airplanes and made his first solo flight when he was a junior in high school. After graduation, he barnstormed around the country at county fairs in Nebraska, Montana, and Wyoming. He moved to Sheridan in 1939, to take flight training in the Civil Pilot Training Program and to get a commercial license and instructor rating. He did commercial flying in Denver for Plains Airways. In 1942 he moved to Raytown, Missouri to finish getting his instructor rating, then moved to Manhattan, Kansas where he was chief pilot and aerobatics instructor. On April 25, 1943, he was united in marriage to Dorothy Rex in Raytown, Missouri. The couple moved to Sheridan where Howard was chief pilot and instructor for Big Horn Airways (then owned by Curley Witzel and Bob King.) When Howard was doing antelope surveys for the State of Wyoming, he met Frank Robbins who asked if he would corral the wild horses on the Red Desert by plane. They started the round up in the summer of 1943. He was called the "Flying Cowboy." In January of 1944, Howard was called into the army where he received his commission as 2nd Lieutenant in the Army Air force at Douglas, Arizona. He joined the 5th Ferrying group based in Great Falls,

Casper – ASCPR04: Once daily flight to Salt Lake City, UT on Delta Connection operated by SkyWest beginning July 1, 2023 through June 30, 2024. In July, the flight began operating on a CRJ-900, increasing seat capacity to 76, which has contributed to lower load factors. The load factor in March was at 61% and April's load factor was at 53%. May's booked load factor is currently at 45.5%.

<u>Original Scope</u>: Once daily service to Salt Lake City on Delta Connection operated by SkyWest Term: July 1, 2023 through June 30, 2024

State Match: \$320,000 / 40%

Capacity Purchase Agreement (CPA):

In July, we began the second year of the second threeyear term of the CPA contract with SkyWest. Block hour rates for this year increased on average 3% from the previous year. While all markets are still lacking needed capacity, two flights each week were added to the schedule for Riverton and Rock Springs in May, and Gillette and Sheridan gained an additional two flights per week beginning November 1st.

Northeast Wyoming Regional Airport-Gillette (GCC): Load factors continue to be strong, with March at 82% and April at 84%. The booked load factor for May is currently at 69%. SkyWest was able to add two additional flights to the schedule each week in November, bringing the total weekly flights to 14.

Original Scope: Additional third daily roundtrip on peak days, daily during the summer months. Reduced frequencies were implemented in April 2020 but beginning in June 2021 flights were restored to the original scope of 3 daily and reduced to 2 daily starting in November, falling again to 12 per week in January 2022. Two additional weekly frequencies were added back to the schedule beginning November 1, 2023.

<u>Term 1</u>: July 1, 2022 - June 30, 2023 <u>Grant</u>: \$2,660,000 / 60% <u>Term 2</u>: July 1, 2023 - June 30, 2024 <u>Grant/State Match</u>: \$2,760,000 / 60% <u>Term 3</u>: July 1, 2024 - June 30, 2025 <u>Grant/State Match</u>: \$2,880,000 / 60%

Southwest Wyoming Regional Airport-Rock Springs (**RKS**): March saw a load factor of 75.5%, while April was at 74%. The booked load factor for May is at 58%. SkyWest's crew-driven flight reductions starting in February 2022 had limited the market to one daily trip; however, a second flight two days each week was added back to the schedule in May, bringing the total weekly flights to 9.

Original Scope: Two daily roundtrips, 3rd daily

Jun - Aug. Post COVID, the market retained close to daily service up until June 2021 when it increased to double daily. As of February 2022,

In mid-February 2022, the market dropped to one daily flight because of SkyWest crew constraints; however, a second flight two days each week was added back to the schedule in May, bringing the total number of weekly flights to 9.

Sheridan County Airport (SHR): Sheridan saw a 74.5% load factor in March and a 72% load factor in April. The booked load factor for May is at 66%. In early January 2022, the schedule was reduced to 12 flights per week; however, beginning November 1, 2023 two additional flights each week were added to the schedule, bringing the total weekly flights to 14.

<u>Original Scope</u>: Two daily roundtrips starting January 12, 2020. Overnight flight tagged with Riverton (RIW). Reduced to one flight daily for April and five times weekly for May and June.
