Please include this letter of support from Yellowstone National Park with the Transportation Investment Generating Economic Recovery (TIGER III) Grant application for the Beartooth National Scenic Byway reconstruction. The National Park Service (NPS) has had maintenance responsibility of the Beartooth Highway since its completion in 1936. This highway passes through the Custer, Shoshone, and Gallatin National Forests on its way to the Northeast Entrance of Yellowstone National Park. The outstanding scenic quality of this unique route has been demonstrated by the Federal Highway Administration's designation of this road as an "All American Scenic Byway."

The NPS has performed road maintenance and snowplowing on this road since the 1930s. In 1996, the Beartooth Highway Steering Committee, comprised of executives from five state and federal agencies and local government representatives, all with an interest in maintaining the route, began to meet with the intention of finding a long-term solution for keeping the Beartooth open and maintained. This innovative partnership has matured over the years, building collaborative partnerships across state and federal jurisdictions to assure long-term access. Bringing this road up to modern highway standards will assist in the endeavor. The Committee's number one goal is to ensure that the condition of the Beartooth Highway is improved and sustained to minimize costly reconstruction to minimize life cycle costs in the long term.

It was this local interest that supported the passage of the Park Approach Act (H.R. 12404) on January 31, 1931. This Act gave the Secretary of Interior authority to designate approach roads to parks. Funds authorized by the Park Approach Act and Forest Highway and Federal Aid programs were used in the construction of different sections of the Highway. This legislation led to a road that enhanced the tourism economy of the greater Yellowstone region. Since 1945, the National Park Service has maintained 43 miles of the Highway with the State of Montana maintaining the Highway from milepost 60.0 to 43. Road maintenance includes road repair work, spring snow plowing and road opening, and plowing needed due to spring, summer and fall snow storms prior to the mid-October road closure date.

This national treasure is essential to the economies of Red Lodge and Cooke City, Montana, Cody, Wyoming, and all the small businesses in between. The economies of Billings and the communities in the greater Yellowstone area are also influenced by this scenic wonder.

Given fiscal realities and the need to support the tourism-oriented economies of this region, the Strategic Goals for the Beartooth Highway are:

- o Clear and open the Beartooth to travel by Memorial Day annually
- o Manage the Highway so it remains open to travel with a paved surface
- Obtain reliable Federal funding to reconstruct bridges or other projects as identified by MDT, WYDOT and Central Federal Lands

A long-term investment in the Highway would yield benefits in the reduction of environmental impacts to a fragile ecosystem, improved visitor safety, improved level of service, reduced operations and maintenance costs, and would provide immediate employment opportunities in the construction and services sectors.

Additional benefits include supporting tourism goals to "brand" the western outdoor experience with high quality natural beauty, small town charm, and a pleasurable travel experience. These investments in the infrastructure of tourism yield long-term employment opportunities. Please consider this investment into one of America's treasure.


