I. Call to Order

The Public Safety Communications Commission met via videoconference on, Wednesday, October 7, 2020. Chairman Harshman presided, calling the meeting to order at 10:00 a.m.

II. Pledge of Allegiance

Chairman Harshman led the Commission in reciting the Pledge of Allegiance.

V. Adjustments to Agenda

There were no adjustments made to the agenda.

VI. Action Items

1. Draft Minutes - July 8, 2020

It was moved by Commissioner Honecker, seconded by Commissioner Frank, and carried to approve the minutes from the July 8, 2020, business meeting.

2. WyoLink Applications

It was moved by Commissioner Frank, seconded by Commissioner Williams, and carried to approve WyoLink Applications for the State of Nebraska, Office of the Chief Technology Officer, and the Converse County Assessor.

VII. Updates/Discussion

1. Director's Update

Director Reiner presented the Director's update.

Coronavirus (COVID-19) Agency Impacts

He conveyed that the agency is operating well during this coronavirus environment, given the rapidly increasing numbers throughout the state. He noted that roughly 20 percent of the workforce remains on telework, and that there have been no instances of cross contamination from employee to employee to date.

Employee Fatalities

He conveyed that the agency has had three fatalities, one job related, and expressed his condolences to the families. He explained that Ms. Shirley Samuelson passed away while on duty and operating a sweeper on Teton Pass, noting she stepped away from her vehicle, and although the emergency break was used, the machine rolled down the hill and over the top of her. He stressed that an ongoing OSHA investigation is underway, and that a future memorial ceremony will be held in her honor.

Federal Budget

He conveyed that an extension and continuing resolution passed for the Fixing America's Surface Transportation (FAST) Act, and that funds were also recently added to the Highway Trust fund.

State Budget

He noted that various cost saving measures are underway, including the closure of various rest areas, various cuts to cities and counties, and 11 significant project delays.

State Legislative Matters

He announced that the agency testified before the Joint Transportation, Highways & Military Affairs Committee on September 21, 2020. This included passage through the committee of a proposed bill that would implement a Road Usage Charge (RUC) for those traveling on the state's highway system. He explained that amendments are underway at this time based on the committee's recommendations, and that changes will be considered at their next meeting. He noted that legislation is also under review regarding employee moving expenses, and stressed the importance of this legislation in growing future WYDOT leaders.

2. Chief Technology Officer's Update

Mr. Babbitt presented the Chief Technology Officer's update.

NG911

He announced the recent hiring of Ms. Aimee Binning in District 1, which includes training and safety oversight for the district, as well as the added role of planning and coordination of the NG911 framework moving forward. He also expressed his appreciation to Mr. Steve Morgan and Mr. Monte McClain for their work on the annual report, noting that they were instrumental in getting this completed.

CARES Act/Broadband

He explained that even though WyoLink did not receive an exception request for COVID-19-related expenses, that the agency was authorized to fund one-third of its original request to update equipment that is no longer under warranty. He conveyed that the partnership between WYDOT and Motorola has been exceptional, and the plan is to replace outdated equipment within the next three biennia. He also conveyed that the Broadband Task Force is discussing the possibility of utilizing WyoLink towers for broadband expansion statewide.

3. Emergency Communications Program Update

Mr. Smolinski presented the Emergency Communications Program Manager's update. The update also included information presented by Mr. Gardiner regarding WyoLink operations.

16-Tower Buildout Update

He reviewed the 16-tower buildout report, which included the following updates:

- **Buffalo:** Site active, with reported coverage in previous known trouble spots.
- **Orin Junction:** Site active, with reported coverage improvements in previous known trouble spots
- **Wright:** Site active, with reported coverage improvements in previous known trouble spots.
- **Jackson:** FNE optimization scheduled for October 19, followed by testing and activation.
- **Alcova:** Zoning hearing was scheduled August 11, and approved on August 18. Broke ground the week of August 31. Building tower on site.
- **Alva:** Broke ground on June 23; fiber installation underway. FNE optimization schedule for October 12, followed by testing and activation.
- **Greybull:** Broke ground the week of September 7. FNE optimization schedule for 10/12, followed by testing and activation.
- **Lusk:** Broke ground the week of September 7. FNE scheduled for the first week of November, followed by testing and activation.
- **Rock Springs (Blairtown to Tank Hill):** Relocation of the site was required. NEPA/SHPO underway; expected ETA by the end of October.
- **Newcastle:** Work continues with the city and a private landowner.
- **Ten Sleep (Meadowlark):** USFS agreement completed. Final submittals to the USFS being delivered.

16-Tower Buildout Update (Continued)

- **Rock Springs (14 Mile Hill):** BLM agreement completed. Tribal and BLM paleontologist will be on-site for construction monitoring. Due to antelope winter migratory route, construction may only occur between May 1 and November 15.
- **Evanston:** Right-of-Way finalizing agreement with private landowners. Scheduling construction and utilities upon agreement.
- **North Big Horn County (Little Sheep Mountain):** NEPA/SHPO underway; expected ETA by the end of November. Spring-Fall 2020 target.
- **Northern Goshen County:** New location identified on State Lands, and survey underway. Summer-Fall 2020 target.
- **Bondurant:** Holding discussions with Sublette and private landowner for a possible collocation option on Kismet Peak. Summer-fall 2020 target.

Statewide Interoperability Coordination

Mr. Smolinski conveyed that work continues with Sublette County in order to finish work on the inner-subsystem interface connection, highlighting that the connection is now in place, and the systems are able to speak to one another. He noted that they are in final testing at this time. Additionally, he conveyed that the WyoLink office is considering options for expanding the inner-subsystem interface connections outside Wyoming's borders. Discussion is ongoing with Colorado, Nebraska, and Idaho.

The Department is preparing an RFP to acquire bulk radio purchase rates for use by WYDOT, other state agencies, and local partners, with an anticipated release in early 2021.

He then announced the formation of a communications leadership technical assistance program that will add in the development of common leadership in interoperability around the state.

His final item was to announce the retirement of Mr. Larry Mayberry with Motorola, noting that he was instrumental in some of the work and partnerships on the WyoLink system.

WyoLink Operations

Mr. Gardener announced that the WyoLink office is making updates at this time, which includes a new ticketing system for tracking requests, a revamped website to reflect where the system is today, and to update outdated information such as the handbook and site maps.

FirstNet

Mr. Garrett Doyle, Colorado's FirstNet marketing manager, provided a brief presentation about the background of the FirstNet/AT&T buildout.

VIII. Adjournment

It was moved by Commissioner Bertoglio, seconded by Chairman Harshman, and carried to adjourn the meeting. Chairman Harshman adjourned the meeting at 11:37 a.m., on Wednesday, October 7, 2020.



 - Site active (3/24/20) with reported coverage improvements in previous known trouble spots
- Orin Junction
 - Site active (4/20/20) with reported coverage improvements in previous known trouble spots
- Wright
 - Site active (6/26/20) with reported coverage improvements in previous known trouble spots
- Jackson
 - Site active (announced 1/11/21) with reported coverage improvements in previous known trouble spots
- Greybull
 - Site active (announced 1/11/21) with reported coverage improvements in previous known trouble spots
- Lusk
 - Site optimization schedule for the first week of February; and will go live following successful testing
- Alcova
 - Site optimization schedule for the second week of February; and will go live following successful testing
 - Kick-off meeting held with Motorola and Natrona County to begin the migration of equipment
- Alva
 - Equipment has been optimized
 - Fiber optic installation underway
- Rock Springs (Blairtown-Tank Hill)
 - NEPA/SHPO & ROW have been completed
 - Ground breaking to be scheduled upon utility certification (approx 2-3 wks)

4.9 GHz Spectrum Status Update

Summary of Events



- March 23rd 2020: “FCC proposed action to promote more flexible and intensive use of the 4.9 GHz band, a segment of spectrum designated for public safety communications.”
- Sept 1st 2020: FCC announced that they would be voting on spectrum on the 30th.
- Sept. 29th: A meeting was held with all the WY 4.9 stakeholders with a Statewide 4.9 License and agreed that WYDOT EC would be the lease holder for WY and only Public Safety Entities would be allowed to use the spectrum.
- Sept 30th: FCC voted 3-2 to lease the spectrum to States.
- Dec 30th: Public Safety Spectrum Alliance filed petitions for a stay of the band and to vacate the FCC’s vote on Sept 30th.
- Jan 21st 2021: PSSA has had a webinar panel discussion about the petitions. The petition is to have the FCC retract it’s vote so they can get input on rules/guidelines for States to be lessors of the spectrum. Currently each State would set the rules/guidelines for leasing the spectrum to WISP’s if they chose to.
- The spectrum is in a holding pattern until there is a ruling on the petitions and it may be a while longer since there are new personnel being appointed to the FCC.

WYOMING STATE STATUTE, TITLE 09, ARTICLE 11
PUBLIC SAFETY COMMUNICATIONS COMMISSION

9-2-1101 – COMMISSION; CREATED; DEFINITIONS:

- (a) The Public Safety Communications Commission is created.
- (b) As used in W.S. 9-2-1101 through 9-2-1104:
 - (i) "Public Safety Agency" means any federal, state or political subdivision entity that provides emergency and public safety services, including state agencies employing peace officers enumerated in W.S. 6-1-104(a)(vi)(C) through (F) and approved for participation by the communications Commission, fire management services, correctional services, emergency management, emergency and disaster relief services and if desired, county, municipal and federal law enforcement agencies;
 - (ii) "System" means the wireless communications network providing regional and statewide radio communications capabilities to public safety agencies.

9-2-1102 – COMMISSION; COMPOSITION; APPOINTMENT OF MEMBERS; REMOVAL; TERMS; OFFICERS; VACANCIES; MEETINGS:

- (a) The Commission shall consist of eleven (11) voting members to be appointed by the governor and who may be removed by the governor as provided in W.S. 9-1-202. The Director of the Wyoming Department of Transportation, or his Designee, shall serve as an Ex Officio nonvoting member of the Commission. The eleven (11) voting members shall be appointed from each of the following associations and agencies from their membership:
 - (i) Wyoming Police Chiefs Association;
 - (ii) Wyoming Sheriffs Association;
 - (iii) Division of Criminal Investigation, Office of the Attorney General;
 - (iv) Wyoming Game and Fish Department;
 - (v) Wyoming Department of Transportation;
 - (vi) Repealed by Laws 2017, ch. 17, § 2.
 - (vii) Repealed by Laws 2017, ch. 17, § 2.
 - (viii) Wyoming Fire Chiefs' Association;

(c) The Commission shall elect from its members a Chairman, a Vice-Chairman and a Secretary. Vacancies in these offices shall be filled by the Commission from its membership. The Commission shall meet at least once every three (3) months. Appointments by the governor shall be made within thirty (30) days of expiration of membership terms. Nominee lists shall be furnished within ten (10) days upon expiration of any membership term. Each member shall serve a three (3) year term. A vacancy on the Commission shall be filled for the unexpired term by the governor.

(d) The person appointed to the Commission pursuant to paragraph (a)(v) of this section shall be the Chief Technology Officer of the Wyoming Department of Transportation, or another employee of the Wyoming Department of Transportation who oversees information technology, or telecommunications systems.

9-2-1103 – COMMISSION; COMPENSATION OF MEMBERS:

Members of the Commission shall receive mileage and per diem provided state employees.

9-2-1104 – COMMISSION; POWERS AND DUTIES; ADVISORY CAPACITY TO PROMOTE SYSTEM DEVELOPMENT; PUBLIC MEETINGS; CLERICAL AND ADMINISTRATIVE SUPPORT:

(a) The Commission shall:

- (i) Work with the budget division of the Department of administration and information, the Department of enterprise technology services, the Department of homeland security and the Department of transportation in an advisory capacity to promote the development, improvement and efficiency of public safety communications systems in the state;

- (ii) Report in writing each year to the governor and the joint transportation, highways and military affairs interim committee concerning any problems related to the installation, operation and maintenance of the system and shall make any recommendations it deems appropriate as a part of the report;
 - (iii) Submit a plan for statewide system networking to the Department of enterprise technology services for inclusion in the statewide telecommunications plan developed pursuant to W.S. 9-2-2906(g);
 - (iv) In cooperation with participating federal agencies, establish and assess user fees upon any federal law enforcement agency electing to use and participate in the system;
 - (v) Promulgate necessary rules and regulations governing system operation and participation and upon failure to comply with adopted rules and regulations, may suspend system use and participation by any participating and noncomplying Public Safety Agency or private entity;
 - (vi) Determine the participation of public safety agencies and private entities in the wireless communications network;
 - (vii) On or before May 31 of each odd numbered year, submit to the governor and the joint transportation, highways and military affairs interim committee a report covering the period beginning July 1 of the following year and ending June 30 in the fourth succeeding year detailing the expected costs of implementing the statewide system networking plan. The report shall include projections of one-time and recurring costs.
- (b) The Commission may hold public meetings throughout the state and may take other appropriate measures to maintain close liaison with regional, county and municipal organizations and agencies involved in the system.
- (c) Necessary clerical and administrative support for the Commission shall be furnished by the Wyoming Department of Transportation.
